

## GLOBAL PRODUCT STRATEGY SAFETY SUMMARY

### EMULGEN 320P

*This document is a high-level summary provides usage of chemical substances and safety information to the general public. It is not intended to replace the Safety Data Sheet, which is available from suppliers and should be referred to for full details of recommended safety procedures for each type of use. It is not intended to replace or supersede manufacturer's instructions and warnings for their consumer products containing this substance.*

#### 1. Substance Identity

Brand Name: EMULGEN 320P

Chemical Name: Polyoxyethylene (13) stearyl ether

#### 2. Uses and Applications

EMULGEN 320P is a nonionic surfactant. EMULGEN 320P is characterised by low skin irritation and is used as an emulsifier in quasi-drugs and cosmetics.

In industrial applications, EMULGEN 320P is used as an emulsifier for paints, coatings and fabric processing agents due to its low damage to textiles.

#### 3. Physical/Chemical Properties

EMULGEN 320P has no identified physicochemical hazards.

#### 4. Human Health Safety Assessment

Consumer: The exposure to EMULGEN 320P is at safe levels.

Worker: The repeated exposure of EMULGEN 320P does not cause any toxic effects.

Effect Assessment	Result
Acute Toxicity oral/dermal	Harmful if swallowed. Based on the available data, no acute toxicity after dermal exposure in practical use. The substance does not cause damage to any organs following single exposure.
Irritation skin/eye	Based on the available data, unlikely to cause skin irritation. Undiluted substance causes serious eye irritation.
Sensitization	Based on the available data, unlikely to cause allergic skin reaction.
Toxicity after repeated exposure	Unlikely to cause any toxic effects through prolonged or repeated oral exposure in practical use.
Mutagenicity	Based on the available data, unlikely to cause genetic defects.
Carcinogenicity	Based on the available data, unlikely to cause cancer.
Toxicity for reproduction	Based on the available data, unlikely to be damaging to fertility or the unborn child.

#### 5. Environmental Safety Assessment

The test results with fish, aquatic invertebrates and algae suggest that EMULGEN 320P could cause a toxicity to aquatic organisms. However, EMULGEN 320P is unlikely to persist in the

environment because of showing the readily biodegradation. EMULGEN 320P does not bioaccumulate in the food chain.

Effect Assessment	Result

Biodegradation	Readily biodegradable.
PBT/vPvB conclusion	Not persistent in the environment, not bioaccumulating in organisms and not toxic nor very persistent and very bioaccumulating.

## 6. Exposure

### Consumer

The consumer can come into contact with the substance in use of the cosmetic products, but the concentration of EMULGEN 320P in use is below the level which would give rise harmful effects of concern. When it's used as the recommended use, consumer should always read product information before use and follow the label/ use instructions.

### Worker

The exposure can occur either in EMULGEN 320P manufacturing facilities or in the various industrial facilities when EMULGEN 320P is used. Those workers in industrial operations during maintenance, sampling, testing, or other procedures could be exposed with EMULGEN 320P. Only qualified and trained workers handle the undiluted substance. The manufacturing facilities offer thorough training program for employees and appropriate work processes, as well as safety equipment (goggles and gloves) in place to prevent an unnecessary exposure. Safety showers and eye-wash stations are accessible nearby. Workers are required to be trained in accordance with the safety measures in the Safety Data Sheet.

### Environment

EMULGEN 320P is discharged to waste water treatment facilities from industrial sites such as manufacturing, preparation, handling, storage and use of the substance. However, the substance is readily biodegradable, so that it is removed efficiently in waste water treatment facilities. The substance is biologically degraded in the surface water and is rapidly removed even if it is remained slightly in the waste water. Hence, the chronic exposure to aquatic organisms of the substance is unlikely to occur. Furthermore, the substance does not accumulate in the food chain, so that there is no concern of human exposure through environmental pathway.

## 7. Risk management recommendations

When you use the substance, make sure to be measured the adequate ventilation. Always use appropriate chemical-resistant gloves to protect your hands and skin and always wear eye protection equipment. Do not eat, drink or smoke where the substance is handled, processed or stored. Wash hands and skin after contact with the substance. When the substance attaches to skin (or hair), wash with a large amount of water and soap. When it

causes your skin irritation, consult doctor (medical diagnosis/therapy). If the substance gets into your eyes, rinse your eyes thoroughly for several minutes. If you wear contact lens, and you can take it off easily, take it off and continue to rinse your eyes. If eye irritation persists, get medical help.

Waste water containing the substance must be passed the waste water treatment facilities in order to remove the substance. No specific measures are needed, because it is not expected to be released into the air.

## 8. Regulatory Information / Classification and Labelling

Under GHS classification chemical substances are classified in hazards for physical properties, human health and environment. The hazard information for industrial products are transmitted via specific labels and Safety Data Sheet. GHS offers the standardization for hazard communication. The subjects who could be assumed to be exposed to the substance, workers, consumers, transport workers, and emergency responders, can better understand the hazards of the chemicals in use through the transmission.

### Labeling according to UN GHS

UN GHS is the basis for country specific GHS labeling.

EMULGEN 320P may be assigned to following GHS classification.

## 9. Conclusion

EMULGEN 320P could cause a toxicity to aquatic organisms. However, EMULGEN 320P is unlikely to persist in the environment because of showing the readily biodegradation. EMULGEN 320P is not applicable to PBT/vPvB. Contact with the undiluted EMULGEN 320P may cause serious irritation to the eyes. When handling the substance, workers should follow the standard safety measures and refer to the Safety Data Sheet. Consumers will usually not come into contact with the substance bulk and the substance is used diluted products, therefore, it is considered that EMULGEN 320P gives rise no hazardous effects to human health.
